## Conditions of Entry

1. The competition is open to amateur photographers only.
2. The entrant must have taken the photographs entered.
3. The entrant must retain the original photograph.
4. Entrants are requested to limit their submission to two entries.
5. Print Entries:
  - a. Each entry must be accompanied by a signed copy of the official Entry Form
  - b. Photographs must be not less than 6 x 4 inches in size.
  - c. For return of photographs please include a stamped addressed envelope.
  - d. All photographs are sent at entrants own risk.
6. Digital Entries
  - a. Each entry must be accompanied by a copy of the official Entry Form
  - b. Photographs must be not greater than 5MB in size.
  - c. Photographs must be submitted in .jpg format.
  - d. Preferably, all digital photographs should be at 300dpi resolution.
7. The entrant will retain copyright in their submitted entries. However, by entering the competition the entrant grants to the ESAI a royalty free, irrevocable, perpetual, assignable licence to publish and use the entry in any and all media for publicity purposes.
8. Where the entry contains images of people, it is the responsibility of the entrant, and the entrant hereby confirms and warrants, that
  - a. he/she has informed the individual that he/she shall submit the photograph to the ESAI competition and
  - b. that he/she has obtained the individual's consent to the submission of the photograph to the competition and
  - c. the photograph does not infringe either national law or local by-laws.
9. The ESAI have appointed a professional photographer to judge the competition. The Judge's decision on all matters relating to the competition is final and no correspondence will be entered into concerning the competition judging or organisation thereof.
10. By entering the competition, entrants agree to be bound by these terms and conditions.
11. The closing date for receipt of entries is Friday December 30<sup>th</sup> 2011.
12. The winner will be notified by email on Friday January 27<sup>th</sup> 2012.
13. Prizes will only be shipped within the island of Ireland.
